2. . A provisional seniority list of the Training Officer against the vacancies upto the recruitment year 1988 was circulated vide letter No.A.23012/1/96/TA.I, dt. 1.9.92.

The applicant submitted representation against the seniority list. dt. 27.4.93 and 23012/1/90-TA.I/(A-1) rejecting his objections there-by his representation. ~~This~~

This OA ~~was~~ filed for setting aside the impugned proceedings No. 23012/1/90-TA.I, dt. 27.4.93 by which the seniority list of the Training Officers had been ^{fixed} prepared and and for a further direction to prepare the seniority list basing upon the eligible list of Assistant Training Officers as on 31.12.86 ignoring the vacancy position in the so called respective years as all of them were given the same date of promotion w.e.f. 1.1.86 and for a consequential relief to prepare the seniority list basing upon the date of regular promotion, namely, 1.1.86 of applicants and other training officers promoted pursuant to the presidential order upgrading 136 posts of Assistant Training Officers as Training Officers as per A-2.

4. A reply has been filed in this OA. In page-5 of the reply it is stated that the seniority list circulated vide letter dt. 1.9.92 and which was also challenged by the applicants herein have already been superseded by the issue of the provisional seniority list of Training Officer circulated vide letter dt. 27.9.96. Objections have been called for from the applicants and others against the provisional seniority list dt. 27.9.96. The provisional seniority list is yet to be finalised. The applicant submits that he has not filed any representation in view of the pending of the OA. He now submits that he will


withdraw this OA provided liberty is given to him to raise objections against the provisional seniority list dt. 27.9.96 if he consider necessary to raise objections in that connection. It is not clear whether the provisional seniority list dt. 27.9.96 is finalised or not.

The applicant may file his objections if any ^{in the new} ~~in view~~ of the provisional seniority list issued on 27.9.96. That representation should be considered by the respondents if the provisional seniority list dt. 27.9.96 is not already finalised. The applicant should file his representation within 15 days from today. The Provisional Seniority list dt. 27.9.96 should be finalised if it is not already finalised after considering the objections raised by the applicant in his proposed representation.

6. The OA is disposed of as above. No costs.


