Oral Order (per Hon. Mr. Justice K.M. Agarwal, Chairman)


Heard Sri J.V. Laxman Rao for the applicants and Sri K. Bhaskar Rao for the respondents.


1. We are informed by the learned counsel for the applicants as also by the learned Standing counsel for the Department that this case is covered by a decision of Ernakulam Bench of this Tribunal in OA.1784/92 decided on 24-5-1993 and similar other petitions decided by various other Benches of the Tribunal.
2. It is not in dispute that the applicants herein are working as Telegraphists / Telegraph Assistants in various CTOs as the applicants in the other cases before other Benches of the Tribunal were working. They are also aggrieved by the denial of the benefits and refusal to regularise service rendered by them in the Reserved Trained Pool as the other applicants in other petitions were denied. As was prayed by the applicants in other petitions the present applicants have also made similar prayers in this OA. Accordingly, this petition is disposed of in terms of the order in OA.1784/92 dated 24-5-1993 by Ernakulam Bench, and accordingly we direct that :

The applicants are entitled to the same pay and allowances as are applicable to the regular employees for the periods they had worked as RTP short duty Telegraphists/ Telegraph Assistants and all other consequential benefits legally due to them in accordance with law.




3. The application is accordingly allowed as indicated above but without any order as to costs.
