the applicants and learned counsel for the respondents.

2. The first applicant was appointed as Casual Mazdoor on 1-4-1986 and worked till 30-9-1988. The second applicant was appointed as Casual Mazdoor on 1-12-1981 and had worked upto 31-12-1982. The third applicant was appointed as Casual Mazdoor on 1-1-1982 and worked upto 30-9-1983 for 340 days under the control of R-2 & R-3. Thereafter they were not engaged at all.
3. As they have been disengaged in the year 1988, 1983 and 1982 respectively, it is not possible to condone the break in service as they were disengaged *long back*.
4. As they had worked for the Department for 440, 263, and 340 days respectively, they have gained considerable experience in the discharge of duties entrusted to Casual Mazdoors. In view of this they are better equipped to discharge <sup>*the duties &*</sup> as Casual Mazdoors in the Telecom compared to freshers.
5. Under these circumstances the following direction is given :  
  
The applicants should be re-engaged as and when work is available in preference to freshers <sup>*who are not*</sup> herein sponsored by the Employment Exchange. However, in pursuance of this order if they are engaged, none who <sup>*at present as Casual Mazdoor*</sup> are working shall be retrenched.
