Heard Sri P.B.V. Jay Kumar, learned counsel for the applicant and Sri D.F. Paul, learned standing counsel for the respondents.

It is very unfortunate that the applicant ^{has been} ~~has been~~ though three years had already passed. Even now the learned standing counsel for the respondents requests for some time for filing reply. ^{we} We have refused this request as this is a simple case which can be disposed of on the basis of the records available.

3. The applicant in this D.A. submits that he is working as Chief Booking Clerk (CBC) in the scale of 1400-2300 ^{and} ~~was~~ called for selection to the higher grade of Rs.1600-2660 which commenced on 27-12-91. It is stated that this selection had prolonged up to 28-12-92. Thereafter a provisional list was published on 28-2-93 and he was empanelled for promotion to the said higher scale (Annexure-I page-6 to the DA). The name of the applicant is written in hand-writing with pen whereas the other portion ^{in the list dated 28-2-93.} is typed. Hence we are not sure whether the name of the applicant was found in the provisional list issued on 28-2-93.

4. In the meantime Railway Board on 27-3-93 issued certain orders for restructuring of the posts in the commercial cadre. Accordingly it is stated that few posts of Chief Booking Clerk in the scale of Rs.1400-2300 ^{who} ~~was~~ upgraded to the higher grade of Rs.1600-2660. It is not clear whether the applicant was senior enough for consideration for promotion against the restructured

posts.

5. This O.A. is filed praying for a direction to the respondents to promote the applicant to the post of CCC Gr.II in the scale of pay of Rs.1600-2660 at Vizianagaram as per Railway Board's order dt.27-1-93 w.e.f.1-3-93 together with monetary benefits, seniority and all other attendant and consequential benefits.

6. From the material available on the record the following direction is given :-

(1) The applicant should be deemed to have been promoted if his name has been included in the list of names available earlier to 1-3-93 as per his turn;

(2) If he cannot be promoted as above then if he is within the zone of consideration for promotion against the restructured post with effect from 1-3-93 and, if ^{found} eligible for promotion then he should be deemed to have been promoted with effect from 1-3-93 *against a restructured post.*

(3) If he cannot be promoted in pursuance of the directions 1 and 2 above, then his case for promotion to the post of Chief Commercial Clerk in the scale of Rs.1600-2660 should be considered against a vacant post which arose after 1-3-93 provided his name is included in the provisional panel issued on 28-2-93 in his turn.

7. If the applicant is promoted as above then he is entitled






