

In view of the detailed order passed in MA 251/96 separately and as we have vacated the interim order, learned counsel for the Respondents Shri V. Rajeshwar Rao submits that nothing would survive in the O.A. for determination and it may be disposed of. When we enquired from Sri S. Lakshma Reddy, the learned counsel for the applicants about the aforesaid submission, he has stated that he would submit to the orders of the Court.

In our view having regard to the frame of the application, the nature of cause of action pleaded and the relief sought, the O.A. does not survive for any substantial purpose once the interim order is vacated. We therefore dispose of the O.A. on the ground that it does not survive in view of the order <sup>on</sup> of the MA 251/96. However, we <sup>make it</sup> ~~would be~~ abundantly clear that ~~as~~ the disposal of the O.A. shall not <sup>be</sup> construed as a bar if he fulfils the requisite conditions and eligibility ~~and to~~ qualify for the same.
