Heard Shri G.V.Subba Rao, learned counsel for the applicants and Shri N.R.Devaraj, learned standing counsel for the respondents.

2. This OA was filed praying for declaration that the impugned order dated 18/20.11.95 rejecting the applicants' representation for treating them as seniors to R-3 is illegal, unreasonable and to quash the same and for consequential directions to R-1 and R-2 to hold trade test by ~~xxx~~ issue of alert notice after revision of the seniority of the applicants.

3. Out of two applicants, the 1st applicant is senior to the 2nd applicant. Both of them are now working as Binders in HSK ~~III~~ in the Railway Printing Press.


4. R-3 originally joined in RPF. On medical decategorisation, he was taken as Peon in the Printing Press. But while R-3 was promoted to Skilled Grade on 1.8.78 and HSK Gr.II on 1.5.86, the first applicant was promoted as Skilled Grade on 2.1.80 and later he was promoted as HSK Gr.II on 9.4.87. It is thus clear that R-3's promotion to the posts of Skilled and HSK Gr.II are earlier to the dates of the promotion of even the 1st applicant to Skilled and HSK ~~II~~.


5. The seniority list that has to be considered for promotion to the post of ~~HS I~~ is that of ~~HS I~~ HS II. It is manifest from the facts stated above that the date of entry of R-3 to ~~HS I~~ HS II is earlier even to the date of entry of the 1st applicant to the category of ~~HS I~~ HS II. Thus the applicant cannot have any grievance when R-3 was alerted for consideration for promotion to the post of ~~HS I~~ while they were not considered for the same.

6. The question of reservation does not arise in this case, for both the 1st applicant and R-3 are SCs. This OA does not merit consideration. Accordingly it is dismissed even at the admission stage. No costs. //
