Heard Mr.B.S.A.Satyanarayana, learned counsel for the applicant and Mr.N.V.Raghava Reddy, learned counsel for the respondents.

2. The applicant while working as Sub-Postmaster was served with a charge memo No.F.7-1/92/2 dt. 19-5-93 (Annexure-1) under Rule-16 of the CCS(CCA), Rules, 1965. The applicant submitted his explanation. The R-2 vide his proceedings No.Inv/F7-1/92/2 dated 31-12-94 (Annexure-3) found him guilty of misconduct and ordered recovery of sum of Rs.4,000/- from his salary in 20 monthly instalments at Rs.200/- per month with immediate effect.

3. The applicant submits that he has preferred an appeal against the said order of punishment. The appeal is still pending.

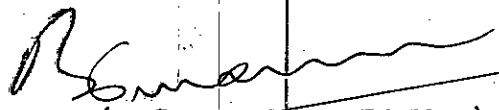
4. The applicant has filed this OA to set aside the impugned order of recovery.

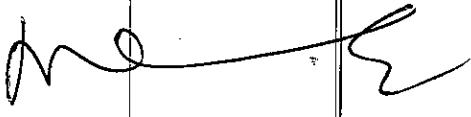
5. The contentions raised in this OA and the prayer asked for in this OA ^{are} similar to OA.113/95. Hence we follow the direction given in OA.113/95 and direct as follows:-

(a) The representation of the applicant dated Nil at Annexure-4) should be disposed of within 2 months from the date of receipt of a copy of this order.

(b) Till such time the appeal is disposed of recovery if any to be made from the salary for the month of December, 1997 and onwards should be suspended till the disposal of the appeal.

6. With the above directions the OA is disposed of. No order as to costs.
