Heard Sri J.V.Lakshmana Rao, counsel for the applicants and Sri N.V.Raghava Reddy, standing counsel for the respondents.

2. There are 3 applicants in this O.A. They were appointed as Electronic Data Entry Operators in the office of Respondent No.2. They were subsequently promoted as Jr.Supervisors in the year 1987. They are working in that capacity from that date onwards. The applicant~~s~~ submit~~s~~ that there are three posts of Sr.Supervisors available in the department and those three posts are kept vacant and the applicants are ^{being} asked to discharge the duties of Sr.Supervisors also without any higher emoluments.

3. This O.A. is filed praying for a direction to the respondents to promote them to the post of Sr.Supervisor.

4. A reply has been filed in this O.A. The respondents submit~~s~~ that there is ~~no~~ necessity to fill the three Sr.Superintendent posts and hence they are not wanting to fill the said posts at the present juncture. It is also stated that none of the juniors of the applicants are promoted over-looking the seniority of these applicants. However, the learned counsel for the applicant submit~~s~~ that the three applicants are asked to discharge the duties of senior supervisor and this is evident from para-5 of the reply.

5. This Tribunal cannot examine whether the duties entrusted to them are of senior supervisor, ^{even though} ~~then~~ they were posted as junior supervisors. However, it is justifiable to direct the respondents to examine their cases if they submit a representation in this




