

ORDER


ORAL ORDER (PER HON'BLE SHRI R.RANGARAJAN : MEMBER (ADMN.))

2. This OA is filed praying for a direction to the respondents to fix the correct seniority of the applicant consequent to his medical decategorisation, taking his length of service rendered in the equivalent or corresponding grade w.e.f., 25-08-73 prior to his medical decategorisation from the date of entry into the grade of Rs.455-700/- (RS) as ASM/SM as provided under para 313 of I.R.E.M. 
