ORDER

{ As per Hon'ble Shri A.B. Gorthi, Member (Admn.) }

The prayer in this application is for a direction to the respondents to consider the request of the applicant for appointment to any Group-D post or as a Postman (Departmental) in the Department of posts on compassionate grounds.

2. The applicant's father died in harness on 02-04-1986 while holding the post of Postman, Prathipadu Sub-Post Office, Kakinada Division. At that time the applicant was a minor. The applicant passed matriculation in March 1991 and immediately thereafter he approached the department with the request for giving him appointment on compassionate grounds to any departmental Group-D post.

3. In the reply statement filed on behalf of the respondents it is stated that the case of the applicant was considered by the Circle Selection Committee on 8/12-12-94 and was approved for giving him appointment to the post of Extra Departmental Delivery Agent (EDDA). The said decision was communicated to the applicant on 23-01-1995.

4. Shri Krishna Devan, learned counsel for the applicant strongly urged before me that the applicant is a matriculate and ^{is the} son of an employee who died while working as a departmental Postman. In view of this it would be more appropriate ^{for} to the department ^{to} consider the case of the applicant for appointment to any of the regular

Group-D posts or the post of Postman (Departmental) in the department of posts. I find that there is merit in this submission made by the applicant's counsel, The department having accepted justification ^{for} ~~of~~ giving compassionate appointment to the applicant, ^{it} ~~there~~ should now consider him for appointment to any regular Group-D post or the post of Postman (Departmental), ^{appointment on} kept for compassionate grounds. Accordingly this OA is allowed with a direction to the respondents to consider the case of the applicant for compassionate appointment to any Group-D post or to the post of departmental Postman in his own ~~turn~~ ^{turn} against the quota meant for such compassionate appointments. ~~applicant the fact that he has not accepted the offer of~~ appointment to the post of EDDA.

5. Respondents shall comply with the above directions within a period of three months from the date of communication of this order. No costs.

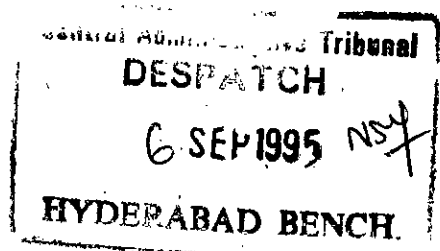
