Heard Shri P.B.Vijaya Kumar, learned counsel for the applicant and Shri C.V.Malla Reddy, learned standing counsel for the respondents.

Assailing the order dated 28.1.1995, whereby the applicant was posted to Koraput.

3. The applicant was promoted as Carriage Foreman by R-2 and he was allotted Waltair Division. R-4 posted the applicant at Koraput.

4. It is stated for the applicant that he had come over from Orissa to Waltair due to domestic compulsions even by foregoing the seniority when he was working as Sr. Train Examiner. As two vacancies of Carriage Foremen were occurring at Visakhapatnam on 30.4.1995, he should have been accommodated in one of those vacancies.

5. We feel that it is a matter for consideration by R-4. Hence, the applicant is free to make a representation to R-4 about his posting at Visakhapatnam
