
Heard Sri N.R.Srinivasan, learned counsel for the applicants and Sri N.R.Devaraj, learned Standing Counsel for the respondents.

2. The applicants numbering 53 herein were directly recruited Technicians. They were selected and recruited by 1-1-1986 and their training period was over prior to 1-1-1986. This was held to treat the training period as service for the purpose of notional increments and to extend the monetary benefits from 1.10.1990.

3. The Bangalore Bench of this Tribunal by the Judgment dt. 26.3.1993 in OA No.156/92 held that the Technicians and other categories who were recruited prior to 1-1-1986 and who had even undergone training prior to 1-1-1986 should also be given the benefit of treating the period of training as service for fixing increments notionally and for giving the monetary benefit from 1.10.1990 in terms of O.M. dt. 22.10.1990.


4. As per the above judgment, the respondents are directed to treat the period of training of the applicants herein as service for fixation of the increments notionally and they should be given the monetary benefit from 1.10.1990. The OA is ordered accordingly. No costs./
