None for the applicant. Heard Mr. Vinod Kumar, learned standing counsel for the respondents.


2. The prayer in this OA is the same as the prayer in OA 1012/96 which is disposed of today. The reply in this OA is also same as the reply in OA 1012/96.

3. In view of the above, the OA is disposed of noting the contentions in para 2 of the reply. No order as to costs.




