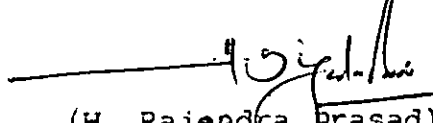

(Oral Order as per Hon'ble Shri Justice M.G. Chaudhari, VC)

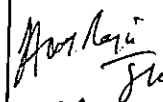
