Heard Mr. K. Venkateswara Rao, learned counsel for the applicants and Mr. K. Bhaskara Rao, learned counsel for the respondents.


2. There are 12 applicants in this OA. They are directly recruited as Technicians. They were selected and recruited prior to 1-1-86 and their training period was also over prior to 1-1-86.

3. This OA is filed ~~for~~ to treat their training period as service for the purpose of notional increment and to extend the monetary benefits from 1-10-90. It is stated that they have submitted a representation in this connection but so far no reply has been received. Hence the OA is filed praying for a relief as noted above.

4. The applicant submits that this case is squarely covered by the order of this Tribunal in OA.No.1423/93 disposed of on 28-3-94. The learned standing counsel also submits that it is a covered case. In view of the above the following direction is given:-


The respondents are directed to treat the period of training of the applicants as service for fixation of the increments notionally and they should be given the monetary benefit from 1-10-90.

5. The OA is disposed of as above at the admission stage itself. No costs.
