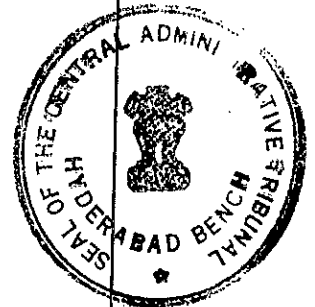

the Respondents are bound to reply to that representation before finalizing the seniority list. If the applicant is going to be aggrieved, he will be at liberty to take appropriate action as he may be advised. In the meantime in order to ensure that the applicant ^{is} ~~should~~ not be put to a disadvantage, his actual date of promotion to TES Group-B should be reckoned to the position of seniority on the adhoc basis till the provisional seniority list dated 6-3-1997 is finalised.

7. In the result the following directions are given :-

"The provisional seniority list issued on 6.3.1997 should be for all the TES Group-B Officers in that cadre as on that date and copy of the seniority list should be circulated in accordance with the law. The applicant is at liberty to submit his representation if he is aggrieved by the seniority shown in that list and that provisional seniority list should be finalised after adjudicating the representations that are received by the applicants herein and others. Till such time the provisional seniority list in pursuance to the above direction is finalised, the actual date of entry of the applicants into TES Group-B should be reckoned for seniority on adhoc basis."

8. OA is ordered accordingly. No costs.
