

Oral Order (per Hon. Mr. H. Rajendra Prasad, Member (A))


Heard Sri Jacob for Mr. B.Narasimha Sarma for the applicant.

1. This is a case of compassionate appointment. The applicant feels that he deserves appointment in relaxation of normal Recruitment Rules on compassionate grounds.
