JUDGEMENT

(ORAL ORDER PER HON'BLE SHRI R.RANGARAJAN, MEMBER (ADMN.))

Heard Mr.S.Kishore, learned counsel for the applicant and Mr.V.Vinod Kumar, learned standing counsel for the respondents.

2. The applicant in this OA while working as Mate (Carpenter) (Skilled) in the Naval Dockyard, Visakhapatnam was issued with a charge sheet dated 13.12.93 for certain misconduct. He was punished under rule 14 of the CCS (CCA) Rules. He was issued with punishment order No.144/D/IP/211/ELC, dated 15.5.95 (Annexure A-1 at page 9




to the OA). He was reduced to the lower post of Mate Carpenter (SS) to the stage of Rs.1030/- in the scale of pay of Rs.800-1150 with other attendant effects. The applicant filed an appeal which was disposed of by the order No. 19013/34/213/ELC, dated 6.12.95 (Annexure A-II at page 10 to the OA) confirming the punishment of the disciplinary authority.


3. This OA was filed for setting aside the proceedings dated 15.5.95 and 6.12.95 and for consequential direction to the respondents to pass such order beneficial to the applicant.

4. The contentions and the prayer raised in this OA are same as the contentions and the prayer raised in OAs 1314/96 and 1432/96. For the reasons stated in those OAs, this OA is also liable to be dismissed. Accordingly, it is dismissed. No order as to costs.
