Heard Mr.Krishna Devan on behalf of Mr.K.G.Krishna Murthy, learned counsel for the applicant and Mr.V.Bhimanna, learned standing counsel for the respondents.

2. The applicant in this OA is the son of one Shri Gangaigh who was medically disqualified to continue ^{his} in service as Postman on 17.1.89. It is submitted that the father of the applicant made a representation dated 15.12.89 seeking employment on compassionate grounds to the applicant herein. By the proceedings LT No.B4/NE/45/89, dated 9.1.90 the applicant's father was informed that his son should apply for compassionate ground appointment after he attains majority. The applicant attained majority on 4.2.92 and thereafter on 7.10.92 the applicant's father requested for compassionate ground appointment to his son, and it is reported that there is no reply to that representation. The father of the applicant had also expired on 19.5.93.

3. The applicant herein submits that there is no earning member in his family except the applicant and he has to be provided with an appointment on compassionate ground due to medical unfitness of his father. He also submits that he has studied upto to 10th class.

4. When the applicant submitted another representation dated 18.3.94, his request for compassionate ground appointment was rejected by the Circle Selection Committee which is impugned in this OA.



5. Whenever the Circle Selection Committee rejects the representation for compassionate ground appointment this Tribunal is consistently taking the view that the case should be reconsidered by the Member Personnel of the Postal Board and issue a speaking order in regard to the request of the applicant. As in this case also the Circle Selection Committee has rejected the case of the applicant for compassionate ground appointment by the impugned order dated 5.10.94 (A-5 page-14) a direction has to be given to Member Personnel Postal Board to dispose of the case of the applicant for compassionate ground appointment in accordance with the rules. If the applicant submits a representation within a period of ^{one} 3 months from the date of receipt of a copy of this order, the Member concerned ^{should} ~~who~~ also take a note of it and dispose of the same.

6. In the result, the following direction is given:-
The applicant if so advised may submit a representation to Member Personnel P&T Board ^{by RPAD} for considering his case for appointment against the compassionate ground quota. If such a representation is received by 30.4.96 the same should be ^{by Member Personnel P&T Board} disposed of in accordance with rules. The Member Personnel should also take note of averments made in this OA while disposing of the representation indicated as above.

7. The O.A. is ordered accordingly at the admission stage itself. No costs.

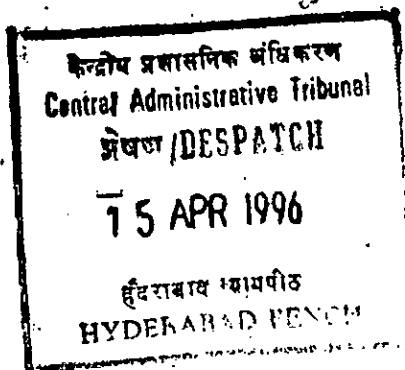
