2. It is noticed that the applicant in this OA had filed

All the facts were comprehensively examined and certain



directions were issued rejecting the claim of the applicant as regards the counting of his past services for pension and increments.

3. The facts urged in this OA are exactly similar to TA.1013/86. There is no scope, therefore, to examine the same set of facts which were urged before this Tribunal once more after the lapse of more than a decade. Apart from that, the case is also time-barred, and attracts the principle of res judicata.

4. The OA is dismissed at the admission stage. No costs.


