

This OA is filed for challenging the letter No.7-27/94/MCG dated 11-7-96 which was communicated by Chief General Manager by letter No.TA/STB/16-1/S.R.T.O.A./Rlgs/11 dated 5-8-96 (Annexure-I) whereby a combined seniority list is to be issued combining the candidates passed in the main qualifying screening test and supplementary qualifying screening test conducted in the year 1994 and 1996. // However, it is now stated by the learned counsel for the applicants that the above said circular dated 11-7-96 has been withdrawn by DOT Memorandum No.7-27/94-MCG Dated 9-9-96 (This O.M. has been taken on record). In view of the above recent development the learned counsel for the applicants submit that he will withdraw this OA presently and approach the Tribunal at a later date if the challenged order is revived.
