


This O.A., is filed for the following reliefs:

- (a) to interpolate the seniority of staff who joined the Survey and Construction Organisation from different construction units i.e., WRKE, CE (Con)BSP, CE(P&D) GRC and open line which were maintaining separate seniority in the individual units based on length of services in a grade etc., and later merged in S & C organisation and order revision of seniority list of PCR, confirmed staff circulated under DCPO/Con/P/BBS Seniority/PCR/01407 dated 29.1.1996(A/18) incorporating the name of the applicant above the juniors mentioned in para 4 of the O.A.
- (b) Till the above is done to suspend the seniority list circulated under DCPO/Con/BBS/Seniority/PR/01407 dated 29-1-1996(A-18).

When the O.A., was taken up for hearing, the learned counsel for the applicant submitted that he is withdrawing the O.A., and will approach the Departmental Authorities for redressal of his grievance.


