be accommodated as Skilled Artisans but an option was given
to them to give their willingness for posting in a Group-D
post as a Khalasi. It is stated for the applicants that they
have given their options within the time. But they have not
been appointed so far either as ~~Skilled Artisan~~ or as Khalasi
in a Group-D post. Hence this O.A. is filed praying for a
direction to the respondents to appoint them as skilled
~~Artisan~~ or as Khalasi (i.e. Group-D post in the scale of
Rs.850-940) in Carriage Repair Shop/Tirupathi, at Diesel Loco
Shed/Kazipet/Guntakal/Vijayawada and Electric Loco Shed,
Vijayawada/Lallaguda and the applicants should be considered
first before considering any other candidates for employment
in Group-D post.

2. The prayer in this O.A. is similar to the
prayer in the O.A.813/95, which was decided on 19-2-95,
wherein both of us were parties to the judgement. In view
of the ~~similarity between this O.A. and OA 813/95~~, we follow
the same direction as was given in OA 813/95. Accordingly
the following direction is given :-



The respondents are directed to offer the applicants herein for appointment as Group-D as and when the vacancies arise in outsiders quota in C.R.S., Tirupathy or anywhere else in Guntakal Division in their turn subject to the condition that the applicants gave acceptance for Group-D post within the stipulated time and also accepted the terms and conditions stipulated therein. The applicants should be considered for appointment in Group-D posts in their turn first, before considering any other outside candidate whose names are not already in the list for appointment in Group-D posts in CRS, Tirupathy or anywhere else in Guntakal Division.
