The applicant declares that the subject matter of the order against which he wants redressal is within the jurisdiction of this Hon'ble Court as the applicant is seeking re-fixation of seniority. ~~in~~

5) Limitation: -

The applicant further declares that the application is within the period of limitation prescribed under law. ~~in~~ Sec. 21 of the C.A.T(R) Rules, 1985.

6) Facts of the Case:-

a) The applicant is presently working with the respondents 1 to 3 as a Passenger Driver 'A' grade. The applicant was initially appointed by the respondents 1 to 3 on 26-8-1972 as APP Fireman Railways at Bitragunta, Nellore district. In the year 1975 he was promoted as Grade 'A' Fireman. In the year 1976 he was promoted as Diesel Assistant. In the year 1981 he was promoted as A.C.Electrical Traction Assistant. In the year 1984 he was promoted as Shantur Grade 'A'. Upon such promotion, the applicant was transferred from Bitragunta to Vijayawada. In December, 1994 he was transferred again from Vijayawada to Bitragunta to work in the said category. In January, 1987 the applicant was further promoted as a Goods Driver 'G' category at Bitragunta. By proceedings dated 7-1-1992, the applicant was further promoted as a Passenger Driver 'A' grade.

b) On his being promoted as a Passenger Driver 'A' grade, he was transferred from Bitragunta to Rajahmundry. Later in the year 1992 he was once-again transferred from Rajahmundry to Bitragunta in the same category and at present the applicant is working as a Passenger Driver 'A' grade. Thus, from 7-1-1992, the applicant has been working with the respondents 1 to 3 as a Passenger Driver 'A' grade.

c) It is submitted that the 6th respondent was promoted as a Passenger Driver 'A' grade on 9-9-1992 and in the said Proceedings ordered him to report for duty in the said category at Rajahmundry from Bitragunta. The 6th respondent refused to accept the said proceedings in view of the condition imposed and therefore he gave up



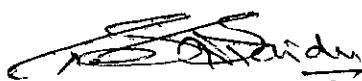

the said promotion. It is pertinent to mention that the 6th respondent's promotion proceedings are subsequent to that of the applicant.

d) It is submitted that the 4th and 5th respondents, by proceedings dated 26-2-1993 were promoted as Passenger Drivers 'A' grade and they were asked to attend duty at Rajahmundry. Both the respondents did not report to duty at Rajahmundry and they refused to accept the said promotion having regard to the condition of their being transferred to Rajahmundry. Once-again the respondents 1 to 3 by proceedings dated 16-5-1994 promoted the respondents 4 and 5 as Passenger Drivers 'A' grade and they were asked to report to duty at Rajahmundry. They refused to do so and accordingly they gave up the proceedings in view of the condition attached to the proceedings. It is pertinent to mention that the respondents 1 to 3 have to effect promotions only once in a year. Giving a go bye to the same, the respondents 1 to 3 for reasons best known to them, on 12-12-94 issued another proceedings promoting the respondents 4 and 5 as Passenger Drivers 'A' grade at Bitragunta itself. Thus, it is seen that the respondents 4,5 and 6 have been promoted long subsequent to the applicant. Therefore the applicant is senior to that of respondents 4,5 and 6.

e) The respondents have issued proceedings dated 4-7-95 ^(Annexed - I 83 A) whereunder they prepared a seniority list. Along with the seniority list, the respondents 1 to 3 have also stated that in the event if any representation is to be made for correcting the seniority list, liberty was given for filing representations. I submit that

in the said seniority list, since my name is shown below the names of the respondents 4 to 6, in terms of the representation, I made a representation on (Amended - II 14) 19-9-1995 and followed it up by reminder dated 17-10-95. (Amended - III 16)

In spite of my representations, the respondents 1 to 3 have not moved an inch in the matter for correcting the mistake in the seniority list. It is apparent that I am senior to respondents 4 to 6. The respondents 1 to 3 have to maintain the correct seniority list, under law and since they have failed to do so, it is submitted that the respondents 1 to 3 have violated the applicant's rights guaranteed under Articles 14 and 16 of the Constitution of India.

f) It is submitted that the respondents 1 to 3 basing upon the seniority list prepared, are treating the respondents 4 to 6 as seniors to the applicant. Further, the respondents ~~4 to 6~~ 1 to 3 basing upon the said seniority list are also making attempts for promoting the respondents 4 to 6 to the next higher category. In view of the fact that respondents 4 to 6 are juniors to me, the respondents cannot act on the said seniority list. The respondents 1 to 3's action in not correcting the seniority list and not placing the applicant as senior to the respondents 4 to 6 is per se violative of Articles 14 and 16 of the Constitution of India.

g) On a reading of the seniority list, itself, it would be evident that the applicant is senior to the respondents 4 to 6. By virtue of the seniority list, prepared, the applicant also put to monetary loss.

h) Hence, under these circumstances, the applicant has no remedy except to seek redressal before this Hon'ble Tribunal. The respondents 1 to 3 being STATE within the meaning of Article 12 of the Constitution of India cannot act whimsically, arbitrarily violating the fundamental rights guaranteed to the applicant under Articles 14 and 16 of the Constitution of India.

~~The~~ The applicant submits that he has no other alternative remedy except to invoke the jurisdiction of this Hon'ble Tribunal and that he has not filed any O.A., petition or Representation for the relief sought for in this Original Application. *e*

8. No matter is pending any other Court. *e*

~~The~~ The applicant declares that he has not filed any matter previously questioning the impugned order in this Original Application.

9) Relief Sought: In view of the facts mentioned in paragraph 6, 7 and 8, the applicant prays for the following relief:

To declare the proceedings dated 4-7-1995 in No. B/P.612/III/Bg/Pass.Drivers of APO (M) / Sr.Divisional Personnel Officer, Vijayawada, in so far as it relates to the fixing of seniority ~~by~~ respondents 4,5, and 6 issued by respondents 1 to 3 showing the respondents 4,5 and 6 as seniors to the applicant, as illegal, violative of Articles 14 and 16 of the Constitution of India and consequently direct the respondents 1 to 3 to set aside the said proceedings with respect to respondents 4,5 and 6 and by correcting the seniority list

I, K.B.T. Naik, S/o Takrya Naik, age 44 years, occupation Government Service do hereby solemnly and sincerely affirm on oath and state as follows:

1. I am working as Senior Divisional Personnel Officer, South Central Railway, Vijayawada, under the administrative control of the Respondent No.2 and as such I am well acquainted with the facts of the case. I am filing this counter affidavit/reply statement on my behalf and on behalf of the respondents 2 & 3, as I have been authorised to do so.

2. I submit that I read the application filed by the Applicant in O.A.No.211 of 1996 and I submit that the material allegations made therein are not true and correct and do not disclose any valid or tenable grounds to grant the relief prayed for in the O.A. The material allegations made therein which are not specifically admitted in this counter affidavit shall be deemed to have been denied by the official Respondents.

3. In reply to Para 6 (b) of the Application it is submitted that the applicant, Sri S. Subramanyam Naidu, Goods Driver/Bitragunta in scale Rs.1350-2200(RSRP) has been temporarily promoted as Passenger Driver in scale Rs.1600-2660(RSRP) purely on adhoc measure pending selection to the post of

Passenger Driver alongwith 32 candidates and all were posted at Rajahmundry, vide Office Order No.B/P.535/III Reg/P.Driver

dated 1-1-1992 (Annexure-I). Subsequently at his request, he was transferred from Rajahmundry to Bitragunta on same Pay and grade, vide Office Order No.B/P.535/III/Rg/Passenger Driver dated 13-7-1992 (Annexure-II).

4. In reply to Para.6 (c) of the application it is submitted that the 6th Respondent, Sri P. Kotaiah, Goods Driver in scale Rs.1350-2200(RSRP) was under orders of temporary promotion as Passenger Driver in scale of Rs.1600-2660(RSRP) purely on adhoc measure pending selection of Passenger Driver and posted from Bitragunta to Rajahmundry vide Office Order No.B/P.535/III/Rg/P.Driver dt.13-7-1992 (Annexure-II) (Para-II as item No.21) Sri P. Kotaiah declined the adhoc promotion as Passenger Driver and expressed his inability to go on transfer to Rajahmundry.

5. In reply to Para 6 (d) of the Application it is submitted that in the similar way the 4th Respondent, Sri S. Srinivasa Rao and 5th Respondent Sri P. Subbaiah, Goods Drivers were also under orders of temporary promotion as Passenger Drivers in scale Rs.1600-2660(RSRP) purely on adhoc measure pending selection and posted to Rajahmundry. But they had expressed their inability to move on transfer to Rajahmundry due to their family troubles, and declined adhoc promotion as Passenger Drivers.

Refusal of temporary promotion purely on adhoc measure will not effect any loss of seniority to empanelment in the selection. The same is mentioned in the order of adhoc promotion under Para-II of Office Orders No.B/P.535/III/Rg/Pass.Driver dt.1-1-1992, which is reproduced below:

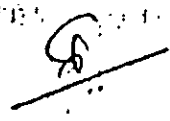

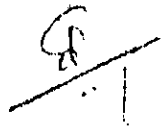

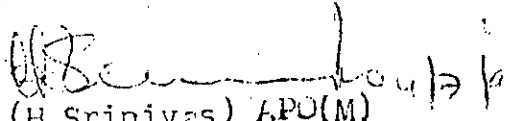

4. 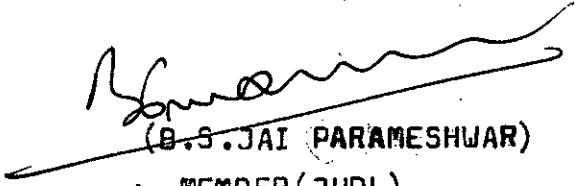

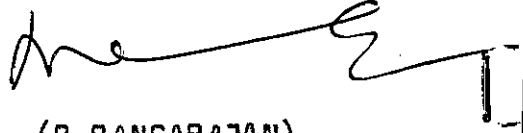

Driver, vide Order No.B/P.608/III/Rg./Pass.Drivers/Sel. dated:2-12-1994 (Annexure.R-IV, page.49 to the Reply). The three Private Respondents stand at serial nos.9, 14 and 16 respectively in that list, whereas the applicant stands at serial no.40 in that list.

4. The main contention of the applicant in this OA is that, as he was working as an adhoc Passenger Driver, he should have been shown as senior to the private respondents 4 to 6, who ^{with} ~~are~~ not promoted on adhoc basis earlier when he was promoted as adhoc Passenger Driver by Order dated:1-1-1992. Hence, he claims seniority in the cadre of Passenger Driver above that of Respondents 4 to 6. The provisional seniority list of Passenger Drivers was also published, vide Letter No.B/P.612/III/Rg./Pass.Drivers, dated:4-7-1995(Annexure-V to the reply), ^{calling} ~~claiming~~ for representations from the Staff, whose name figures in that list. The applicant is shown junior to the Respondents 4 to 6, even in that provisional list.

5. This OA is filed for showing the applicant as senior to respondents 4,5 and 6 in the seniority list issued on 4-7-1995, with all consequential and attendant benefits.

6. The applicant submits in Para.6(e) of the OA that, he has made a representation on 19-9-1995 (Annexure.II, page.14 to the OA). In the reply, it is stated that such a representation was not received. The learned Counsel for the Respondents could not also
