Heard Sri V.Bhimanna, standing counsel for the respondents. Respondent No.4 called absent.



From this office order, it is seen that the applicant was allowed to continue on regular basis on being placed on the select list in the post of Head Clerk in the scale of pay of Rs.1400-2300 (RSRP). 
5. In view of the office order referred to above, the OA has become infructuous. Hence the OA disposed of as having become infructuous. No costs.
