
ORDER

1 As per Hon'ble Shri R. Rangarajan, Member


This OA is filed for a declaration that the seniority list relating to the grade of Income-Tax Inspectors published by R-1 as on 01-09-1994 in so far as it relates to the applicant and respondents No.2,3 & 4 whereby respondents No.2,3 & 4 are shown as seniors to the applicant ^{is} ~~as~~ illegal, arbitrary and contrar to the directions of the Central Board of Direct Taxes and for a consequential direction to R-1 to refix the seniority of the applicant by placing him above the respondents No.2,3 & 4.

2. When the case came up for admission hearing the learned standing counsel produced the letter Cr.No. 351/Estt./1996 dated 26-02-1996, wherein the applicant is at Sl.No.41, Respondents No.2, 3 & 4 are at Sl.No. 75, 77 and 48 respectively. Thus as per the letter produced by the learned standing counsel for the respondent the applicant is shown as senior to R-2, 3 & 4 as per the memorandum dated 26-02-1996. In view of the above the OA becomes infructuous.

3. In the result, the OA is dismissed at the admission stage itself as infructuous. No costs.
