Heard Sri Jacob for Sri B.Narasimha Sharma, counsel for the applicant and Mrs.Shakti for Sri J.R.Gopal Rao, learned standing counsel for the respondents. There are two applicants in this OA. Notice has been served on Respondent No.5 but not served on Respondent No.4. In view of the directions ^{that is} going to be given in this OA, even if it is not served on Respondent No.4, it does not cause any harm to Respondent No.4.

2. This OA is filed praying for declaration that the impugned proceedings No.B/P.535/VI/3/YS dt.15-9-95 whereby the Respondent No.4 and 5 were absorbed as SS/TI in the scale of Rs.1600-2660 and the proceedings No.B/P.535/VI/Optg/SM/Dy.SS/Vol.3 dt.1.11.95 whereby they were repatriated as Dy.SS from 15-5-87 ~~as~~ arbitrary and illegal and for a consequential direction to the respondents to adhere to the avenue of promotion chart exclusively meant for Station Masters category vide P(T) 529/Optg/Channel dt.3-7-84 for promotions to any grades in the category of Station Masters.


3. When this OA was taken up for hearing, the learned counsel for the applicant submits that in view of the recent judgement of the Supreme Court, respondents 4 and 5 were brought down in the category of Station Masters below that of the applicants. Hence their seniority is not effected on bringing the party respondents into Station Masters category. In view of the above, the applicants ~~does~~ not stand to lose ~~promotion~~ or ~~in~~ any other ^{benefit} ~~aspect~~.


