There are 31 applicants in this OA. They were all recruited as RTP Short Duty Telegraphists. The period for which they worked as RTP/Telegraphists and the present designation and the office now they are working is given at Annexure -1 (Page-14). As can be seen from A-1 the applicants 1 to 26 & 29 are now working under R4, applicants 27, 28 and 31 are working under R11. The applicant 30 is working under R2. After the period indicated in Annexure-1 when they worked as RTP/Telegraphists their services were regularised in the department.

2. This OA is filed praying for a direction to the respondents that the applicants herein may be paid the Productivity Linked Bonus due for the periods they had worked as RTP/Short Duty staff (as shown in A-1 at pages 14 & 15) by extending the benefit of judgement dated 31.5.94 in O.A.No. 611/94 on the file of this Bench (A-2) as the applicants herein are similarly situated as the applicants in OA.611/94.

3. The case of the applicants in the OA is squarely covered by the order of this Tribunal dated 31.5.94 in OA.611/94 on the file of this Bench. In view of the above the applicants herein are entitled to get the same relief as given in that OA.

4. In the result, this OA is allowed at the admission stage itself with a direction to the respondents to grant the applicants herein the same benefits as was granted by the Ernakulam Bench of this Tribunal in OA.177/89.




