The applicant in this OA is the son of late Shri Y.Narasimha who died while in service ~~in the year~~ 1983. His mother who was also an employee of the same organisation died on 16.3.88 while she was in service. The present family consists of a sister <sup>brother</sup>. He submitted a representation for appointment on compassionate grounds to R2 when he attained majority by his representation dated nil vide Annexure-3. It is stated that the representation is yet to be disposed of. Though he was orally informed that his case for compassionate ground appointment will be considered when he attains the majority.

2. It is also stated that he was <sup>also</sup> employed as a casual labour under R2 for a short period in the year 1988-89.

3. In the above circumstances the following direction is given:- R2 should dispose of the representation (A-3) preferably within a period of 3 months from the date of receipt of a copy of this order. If there is work and there is need for employment for casual labour the case of the applicant may be considered for such casual engagement <sup>in accordance with rules</sup>.


4. The OA is ordered accordingly at the admission stage itself. No costs.
