I As per Hon'ble Shri R. Rangarajan, Member (Admn.) I


This OA was filed praying for a direction to appoint the applicant herein on compassionate ground. The applicant was the son of ~~Late~~ G.Varadaiah who worked as Blacksmith in the SC Railway Vijayawada Division and who expired on 13-08-1973 while in service due to natural cause. The case of the applicant for compassionate ground appointment was turned down by the order No.P/SC/268/MR/90-91/286/DOP/65 dated 23-11-94 (Annexure-I) as this is a belated case and over 21 years old.

2. The applicant request<sup>with</sup> for waiving of Court fee<sub>was</sub> granted by the order of this Tribunal dated 04-04-96 in MA. No. 240/96 in this OA. After that the applicant or his counsel did not care to appear before this Tribunal for admission hearing. Even today when the case is posted for dismissal, neither the applicant nor his counsel was present. As the case of the applicant had already been rejected as time barred by the respondents the case does not merit any<sub>further</sub> consideration.

3. Hence, the OA is dismissed at the admission stage itself.
