ORDER

1. As per Hon'ble Shri R. Rangarajan, Member (Admn.) X

This OA is filed praying for a direction to the respondents to finalise the selection for which notification was issued by R-3 under office memorandum No. B-4/232/94 dated 31-10-94 (Annexure-I) and appoint the applicant on regular basis.

2. The facts of this case are as follows:-

The applicant is working as Provisional EDBPM Kundum post office under R-3 from 05-10-1994. A notification dated 31-10-94 (Annexure-I) was issued for selecting a regular candidate ~~for the post office~~ to be posted as EDBPM. It is stated that four candidates responded to this notification including the applicant. Though more than 18 months ^{had} ~~are~~ elapsed it is alleged by the applicant that the selection in pursuance of the notification dated 31-10-94 is not finalised. Hence, this OA is filed praying as above.

3. The main contention of the applicant is that since the selection is not finalised for 18 months it should be expedited considering the candidature of the applicant also. He also alleges that there is a move to cancel this notification and approach ^{the} ~~concerned~~ employment exchange for sponsoring fresh candidates. The above reasons are not cause for the applicant to approach this Tribunal by filing this OA. He is already continued ^{Provisional} as EDBPM, Kunduru and an interim order has also been issued dated 17-04-96 to continue him in that capacity. The applicant will have a cause if his candidature for the selection on the basis of the notification dated 31-10-94 is rejected or the notification

itself is cancelled and a fresh notification issued or
employment exchange/^{is} approached calling for sponsorship
of the candidates. No such eventuality have been brought
to the notice of this Court. Hence the applicant has no
cause for filing this OA.

4. In view of the above, there is no need to
consider this OA except giving a direction to the respondents
to continue the applicant as ^{Provisional} EDBPM till a regular EDBPM is
posted to Kunduru post office.

5. The OA is ordered accordingly at the admission
stage itself. No costs.
