Heard Sri M. Kesava Rao, for the applicant and Sri K. Bhaskar Rao, for the respondents.

2. The applicant in this OA was engaged as casual mazdoor from 15-9-1982 under Respondent-1 and he worked on that capacity till 28-2-1983. In para-6(a) of the OA the details in regard to his working as casual mazdoor for various period has been indicated. These details need be checked up by the respondents for their correctness. It is seen from the OA that from 1-8-91 onwards he was not reengaged.

3. This OA is filed ~~for~~ praying for a direction to the respondents to reengage him as casual mazdoor.

4. In the resplt, the following direction is given :

The applicant should be engaged as casual mazdoor in future if there is work in preference to freshers from the open market in the unit from which he was last retrenched. If in pursuance of this order he is going to be reengaged none of the casual labours who are already in casual service shall be retrenched.

5. The OA is ordered accordingly at the admission stage.
