The applicant in this OA was engaged as casual and he worked in various spells up mazdoor from 2.6.81 to 31.5.82 as given in para 6-A of the OA. Thereafter he was not re-engaged. During the period he worked as casual mazdoor it is stated that he had completed 983 days of casual service.

2. This OA is filed praying for a direction to the respondents to re-engage him as a casual mazdoor.

3. The applicant having worked earlier in the department had acquired knowledge in regard to the departmental work. Hence he has to be preferred if there is work in future in preference to freshers from the open market. As he was disengaged after 31.5.82 the long period of absence cannot be condoned.

4. In the result, the following direction is given:-  
The applicant should be re-engaged if there is work in future in preference to freshers from the open market in the same unit from which he was last retrenched. If in pursuance of this order he is going to be re-engaged none of the casual labourers who are already in casual service shall be retrenched.

5. The OA is ordered accordingly at the admission stage itself. No costs.
