

3. When the case came up for hearing today, the learned counsel produced the official file ST 31/WLF/52/1/95. It is seen from page-4 of that file that the case of the applicant was rejected by R-2 considering his financial position and other circumstances. When we asked the learned standing counsel whether the P.M.G. (R-2) is competent to reject the request for compassionate ground appointment without the case being put up to the Circle Selection Committee, the learned standing counsel fairly submitted under instructions that it is the prerogative of the Circle Selection Committee to reject the request for compassionate ground appointment.

4. In view of the above the impugned order dt. 15.3.96 (A-1) is set aside and R-2&3 are directed to place this case before the Circle Selection Committee for final decision.

5. The OA is ordered accordingly. No costs.


