
applicant and Mr. V. Rajeswara Rao for the respondents.

2. The applicant herein was engaged as casual mazdoor w.e.f. 15-7-1984 and has not been engaged after 1-9-1985. His contention is that some of the casual mazdoors who were junior to him have since been re-engaged.

3. There are no legal issues to be examined here. It would be sufficient to direct the respondents to examine the question of considering the applicant's engagement on casual basis, if and when any work is available to be performed. Such engagement, if given to him, will not earn for the applicant any entitlement of the benefit of his previous service, or of condonation of break in service, or of conferment of temporary status, outside the purview of the scheme evolved by the department for this purpose.

4. Thus the OA is disposed of.
