
ORAL ORDER (PER HON'BLE SHRI R.RANGARAJAN : MEMBER (ADMN.))

Heard Mr.P.Bhaskar, learned counsel for the applicants and Mr.N.R.Devaraj, learned counsel for the respondents.


2. There are 7 applicants in this OA. They were engaged as Casual Mazdoor in the years 1991 and 1992 by R-2. They filed this application for a declaration that they are not to be terminated and consequently ~~praying~~ ^{stating} praying for a direction to the respondents to grant them temporary ~~service~~ ^{status} and regularise ~~them~~ ^{their} services in their turn.

3. At present ~~there is~~ ^{has been} no action initiated for the termination as seen from the enclosures to the OA. In Annexure-1 Page-8 some details have been asked for and also concerned field officers were instructed to examine ~~the~~ ^{take} each case of engagement of labour and remedial action for their removal as per rules under the I.D. Act. Hence, we are of the opinion that this is a premature application and need not be entertained at this stage. Hence, the OA is dismissed as premature. No costs.
