The applicant stands at Sl.No.3 in the list. As there was only one vacancy, first on the panel viz., Sri Thavitayya was offered the post. Hence ~~the request~~ ^{of the applicant} cannot be treated as meritorious ^{for} appointment against that post. In view of that, the O.A. is disposed of at the admission stage itself. No costs. (The selection proceedings were perused and returned back).
