The applicant ~~is not~~ is an aspirant for the post of L.D.C. under Respondent-1. It is stated that his name is not sponsored by the employment exchange. Hence relying on the Hon'ble Supreme Court's decision reported in (1996) 6 scale page 676 "~~State Government~~, The Excise Superintendent, Malkapatnam Vs. K.B.N. Visweswara Rao, " the applicant submits that he should also be considered for selection even though his name is not sponsored by the Employment Exchange.


The present OA is filed for considering him to the post of L.D.C. in view of his qualifications and other eligibility conditions.

The application of the applicant for the post of L.D.C. should be entertained and he should be considered for that post along with the employment exchange sponsored candidates. If he fails in the selection, the OA stands dismissed. If the applicant comes out successfully and is within the number to be empanelled then his result should not be published until further orders in this O.A.

~~The OA is thus disposed of. No costs.~~


