


Oral order (per Hon. Mr. H. Rajendra Prasad, Member(Admn))

Heard Sri P. Bhaskar, learned counsel for the applicants and Sri N.V. Raghava Reddy for the respondents.

1. In a similar case in OA.24/97 this Tribunal directed on 3-1-1997 to dispose of the representations of the applicants therein within a period of three months from the date of receipt of copy of those orders.
2. It is submitted by Sri Bhaskar that the present applicants shall be satisfied if similar order is passed, with which Sri Raghava Reddy is in agreement. 
