Heard Mr.K.Nageswara Reddy, learned counsel for the applicant, Mr.N.R.Devaraj, learned counse for R-1 and Mr.Phaneraj for Mr.P.Naveen Rao, learned counsel for R-2.

2. A notification was sent to the employment exchange for sponsoring the candidates for the post of Stenographer under R-1. It is stated that the name of the applicant was not sponsored by the employment exchange. Hence, relying on the Supreme Court judgement reported in 1996 (6) SCALE 676 (Excise Supdt., Malgapatnam, Krishna District Vs. KVN Visweswara Rao), the applicant herein prayed²⁴ for a direction to R-1 to allow him to appear for the test and interview of the post of Stenographer without insisting that his name should be sponsored by the employment exchange.

3. In similar cases this Bench has directed the respondents to allow the applicants to appear for the selection. In view of the precedence R-1 is hereby directed to allow the applicant herein to appear for the selection for the post of Stenographer on the day when ^{selection} interview is to take place. If the applicant fails in the selection then the OA stands dismissed. In case he ^{is} selected and come within the number to be empanelled his results should not be announced ^{until further orders in this OA.} If he fails in the selection the same may be brought to the notice of this Bench for confirming the dismissal. ~~No costs.~~
