Heard Mr.K.Venkateswara Rao, learned counsel for the applicant and Mr.N.R.Devraj, learned standing counsel for the respondents.

2. This OA is filed for promotion to the post of Administrative Officer in the scale of pay of Rs. 2000-3500 from the date on which his immediate juniors, the unofficial respondents were promoted to the said post by the memo No. A-32013/(AO)/96/19A, dt. 10.4.97 with all consequential benefits.

3. The applicant submits that he is an ST candidate and hence he should be promoted if he is found fit for promotion irrespective of the bench mark he obtained.


4. The learned counsel for the respondents submits that his community status has not been established yet. There is an enquiry going on with the Collector to establish his social status by the Collector. That enquiry is not yet over.

5. In view of the above the following direction is given:-

If the applicant establishes his social status fully then his promotion to the post of Administrative Officer should be considered in accordance with the rules if required on par with his juniors.

6. The OA is ordered accordingly at the admission stage itself. No costs.


