Oral order (per Hon. Mr. R. Rangarajan, Member (Admn))

The applicant in this OA is now working as Junior Accounts Officer in the Telecom Department on deputation <sup>basis</sup> from Postal Service. The applicant has submitted his representation dated 8-7-95, 1-3-96, and 10-9-96 to R-1 for his absorption in the Telecom Department. He is continuing his lien <sup>in</sup> ~~from~~ the Postal service. The applicant further submits that there is power to the authorities to regularise vide para 15 of the P&T Board Notification dated 15-4-1977 (Annexure 7 to the OA). He submits that the authorities may consider his case for relaxing the rules and absorb him in the Telecom Wing.
