

Heard Shri V.V.Narasimha Rao, counsel for the applicant and Shri P.Naveen Rao, learned standing counsel for the respondent No.3. None for Respondents 1 and 2.

2. The applicant is an educated unemployed youth. According to him, Respondent No.2 has sought and secured permission of respondent No.1 to fill up certain posts of Attendants and Chowkidars. The Employment Exchange is stated to have sponsored the names of an unspecified number of candidates for these vacancies. According to his information, applicant's name has not been included in the list of the Employment Exchange sponsored candidates. He has filed this D.A. with a prayer to direct the respondents to interview the applicant along with the sponsored candidates for the above mentioned posts.

3. Every purported fact in this case is vague and unsubstantiated. It is not known whether respondent No.2 is conducting any recruitment at all. Similarly, it is not clear how many vacancies exist in each cadre/post. The essential qualifications required of the candidates are not known. It is not clear whether the applicants would fulfill any or all of these qualifications. It is also not known whether any interview is going to take place shortly. The date of such selection/interviews is also not known. It is not known whether or not the applicant's name has been sponsored by the Employment Exchange and if not, the reasons thereof. Everything is based on mere hearsay and unsupported oral statements.

4. This Tribunal in some cases of similar nature had issued certain directions to various respondents in identical circumstances. Consistently with those, the following directions are issued:-


(i) The applicant may submit an application directly to respondent No.2 so as to reach the latter not later than one week prior to the commencement of interviews/selections/recruitments.

(ii) If the application is received as indicated above, Respondent No.2 shall consider his case along with the candidates sponsored by the Employment Exchange.


(iii) If the applicant fails to meet the deadline for submission of the application as indicated above, the OA shall stand automatically rejected.

(iv) If the case of the applicant's candidature is considered but he is not found fit or not selected for the post applied for him, the OA shall stand dismissed.

5. Thus the O.A. is disposed of at the admission stage. No order as to costs.
