Heard Mr.K.V.Rama Rao for Mr.P.Krishna Reddy, learned counsel for the applicant and Mr.V.Rajeswara Rao, learned standing counsel for the respondents.

2. There are 15 applicants in this OA. They are presently working as Diesel Assistants, South Central Railway, Hyderabad. They are aggrieved by the provisional seniority list issued vide memo No.YP/731/ER/HYB/SC, dt. 25.1.96 (A-2 Pages-12 to 20 of the OA). The applicants have submitted a joint representation dt. 25.2.96 to R-2 (A-1). The applicants have submitted that representation in time. But no reply has been issued to that joint representation.

3. The present OA is filed praying for a direction to revise the seniority list dt. 25.1.96 as requested in their representation and proceed further on the basis of the revised list.

4. As the representation of the applicants against the provisional seniority list is not yet disposed of, The respondents are directed to dispose the joint representation in accordance with law and then only proceed further on the basis of the final seniority list.

5. The applicants, if aggrieved by the final seniority list they are at liberty to take such action as available to them under law.

6. With the above direction the OA is disposed of at the admission stage itself. No costs.

7. Registry should send a copy of the OA along with judgement to R-2.
