Heard Mr.S.Lakshma Reddy, learned counsel for the applicant and Mr.V.Rajeswara Rao, learned standing counsel for the respondents.

2. The applicant is an Assistant Station Master in the grade of Rs.1600-2660. A show cause notice bearing No.YP/135/ETII/Restructuring/SM.II, dt. 15.4.97 (A-1) has been issued to

amend the office order dt. 8.8.95 and 10.11.95 to the extent of promotion under restructuring scheme and consequent seniority. The applicant apprehends that his seniority may be brought down thereby he will loose his chance of promotion to the higher grade. The applicant further submits that he had already submitted reply to the showcause notice dt. 15.4.97. In the meantime notification bearing No.YP/535/P.11/3/Selection dt. 19.5.97 (A-7) has been issued for selection to the post of Station Master in the grade of Rs.2000-3200 in Hyderabad Division. If the selection is finalised before disposal of his reply to the impugned showcause notice there is every possibility that he may not be considered for the selection to the post of Station Master in the grade of Rs.2000-3200.

3. This OA is filed to set aside the impugned <sup>show cause notice</sup> ~~notification~~ dt. 15.4.97 and also other consequential proceedings.

4. When we asked the learned counsel for the applicant whether he will be satisfied if the fillingup the posts of SM in the scale of Rs.2000-3200 is kept pending till such time reply to the showcause notice is disposed of by the respondents, the learned counsel for the applicant replied in the affirmative.

5. Hence the OA is disposed of at the admission stage itself as follows:-

The selection to the post of SM Gr-II in the scale of Rs.2000-3200 in Hyderabad Division as per the notification No. YP/535/P.11/3/Selection, dt. 19.5.97 (A-7) should not precede the disposal of the case of the applicant in connection with the impugned showcause notice issued to him on 15.4.97 for which he had already applied.
