2. The applicant aspires to the post of Professional Assistant for which he claims he has the eligibility on the strength of similar promotions stated to have been given to some of his colleagues. The facts, as stated in the O.A., are far from clear. What is clear is that the applicant has submitted a representation on 2-6-1997 (Annexure I to the O.A.,) addressed to Respondent No.3. It is, however, seen that the representation has been addressed to an authority other than the one who is competent to examine and decide the question.

3. It is, therefore, felt that the applicant may now submit a proper representation to the 2nd respondent, through proper channels, within the next 15 days, if he chooses to do so. On receipt of such a representation from the applicant, the 2nd respondent shall have the matter examined on merits and in accordance with the rules of the service/Department and any decision taken in the matter be communicated to the applicant within sixty days of the date of receipt of the representation, if made and received, in the office of the 2nd respondent.






Pursuant to an earlier direction of this Tribunal

his claim for promotion to the post of the Professional Assistant. His grievance is that he has not received any decision or reply so far.


