Heard Sri Y.Appala Raju, counsel for the applicant and Sri N.V.Raghava Reddy, standing counsel for the Respondents 1 to 4.

2. The applicant is the son of late S.Venkatramaiah who died on 25-6-95 when he was working as EDMC, Kandur Branch Office, Kalikiri Mandal in Tirupati Postal Division. The wife of the deceased applied for compassionate ground appointment to her second son. It is seen from Annexure-I, page-17 of the OA that the Circle Selection Committee has rejected the case of the applicant for compassionate ground appointment on the ground that there is no indigent circumstances in the family.

3. The applicant submits that he is ^{belonging} ~~coming~~ from a poor family
 also
 deceased is/not having any properties except a small house in SC/ST colony. Applicant further submits that he is an ST candidate. Hence it is urged that rejection of his case for appointment on compassionate grounds is not in order.

4. This O.A. is filed for appointing the applicant on compassionate grounds. In all similar cases where compassionate ground appointments were rejected by the Circle Office, we are advising the affected candidates to represent their case to the Member (Postal), incharge of staff. As this is also a similar one, we feel that a similar direction will hold good.


5. The applicant, if so advised, may submit a detailed representa-

tion for considering his case for appointment on compassionate grounds to the Member (Postal Services), who is incharge of Staff within 30 days from the date of receipt of a copy of the judgement. If such a representation is received by the said authority, the same should be disposed of within 2 months from the date of receipt of that representation considering all the aspects raised therein in accordance with the law.

6. The Original Application is ordered accordingly at the admission stage itself. No order as to costs.




