
4. The contention raised by the applicant in this OA is similar to the contentions raised in OA.952/97 which was decided on 1-8-97.


 

5. In view of the above we follow the direction given in that OA and direct as follows:-


The applicant if so advised may file a detailed appeal to the appellate authority including all the available contentions to him within a period of one month from the date of receipt of a copy of the judgement. If such an appeal is received by the concerned appellate authority then that appellate authority should dispose of the appeal in accordance with law giving a detailed speaking order on the contentions raised by him within a period of two months from the date of receipt of that appeal without going to the question of limitation.

6. The OA is ordered accordingly at the admission stage itself. No costs.
