2. It is stated that the applicant is working as EDDA in Veeranki Lock BPO whenever the concerned Postman proceeds on leave. It is stated that sponsorship was called for from the Employment Exchange for filling up the post of EDDA, Veeranki Lock. The applicant has produced a call letter issued to one Sri Vadi Kesavulu asking him to submit his application on or before 16-6-97. The applicant requests that his application for that post should also be considered in view of the Supreme Court decision reported in 1996 (6) SCALE 676 In the facts and circumstances of the case the following interim order is given:-

If the selection to the post of EDDA, Veeranki Lock BPO is not finalised till today and it will take at-least a week from today onwards, then the case of the applicant should also be considered for that post if he had submitted an application by now.
