2. The applicant in the O.A. is an aspirant for the post of EDBPM, Pallavolu Village, Chapadu Mandal of Cuddapah District. The applicant submits that the notification for filling up this post by a regular candidate was issued on 7-2-95 (Annexure-1 page-8 to the OA) and he has been asked to submit his original certificates/documents to ASPD, Proddatur (North) by verification letter No.8-3/198 dt.6-4-1995 (Annexure-2 page-11 to the OA). On that no further action was taken to finalise the selection. Respondent No.4 is also an aspiring candidate for the said post.

3. This O.A. is filed praying for a direction to the respondents to finalise the selection to the post of BPM, Pallavolu Village, Proddatur Postal Division on the basis of merit on regular basis thereby terminating the continuation of Respondent No.4 on provisional basis.

4. The prayer in this O.A. is to finalise selection early. The learned counsel for the respondents also submitted that a direction may be given to Respondent No.3 to finalise selection on regular basis.

In the result, the respondent No.3 is directed to finalise the ^{regular} selection for the post of EDBPM, Pallavolu Village,
